AGREEMENT BETWEEN NALF AND MEMBERS. I/WE HEREBY CERTIFY AND DECLARE THAT THE ABOVE IS TRUE AND CORRECT AND I/WE DESIRE TO HAVE THE SAME RECORDED IN THE NORTH AMERICAN LIMOUSIN FOUNDATION (NALF) RECORD, IN CONSIDERATION OF WHICH I AGREE TO ABIDE AND BE BOUND BY THE BY-LAWS, RULES AND REGULATIONS OF THE FOUNDATION AND AMENDMENTS THERETO. I UNDERSTAND THAT ALL SAMPLES SUBMITTED WITH NALF SHALL BECOME THE PROPERTY OF NALF AND UNDER NO CIRCUMSTANCE MAY A PRODUCER REQUEST THAT THEIR DNA OR BLOOD SAMPLE BE RETURNED TO THEM. PARTIES UNDERSTAND THAT ANY OR ALL SAMPLES MAY BE USED FOR RESEARCH. BOTH PARTIES UNDERSTAND THAT STUDIES MAY BE CONDUCTED TO ALLOW NALF TO IDENTIFY CERTAIN BENEFICIAL OR UNDESIREABLE GENETIC TRAITS. NAME OF INDIVIDUAL, RANCHES OR THEIR CATTLE WILL NOT BE IDENTIFIED. I HEREBY CERTIFY THAT THE ANIMALS LISTED WERE IDENTIFIED AT THE TIME OF DNA OR BLOOD SAMPLE COLLECTION BY CHECKING IDENTIFYING MARKINGS SUCH AS REGISTRATION NUMBER, TATTOO, EAR TAG, ETC., AND THAT THE DNA/BLOOD SAMPLES WERE DRAWN IN ACCORDANCE WITH THE PRINTED INSTRUCTIONS ISSUED BY NALF. TISSUE SAMPLES WILL BE KEPT AT NO COST AT NEOGEN FROM THE TIME OF SUBMISSION FOR A PERIOD OF ONE YEAR. AFTER THAT TIME FRAME, THE SAMPLE WILL BE DISCARDED BY NEOGEN UNLESS THE CUSTOMER NOTIFIES NALF TO HAVE THE SAMPLE STORED AT NEOGEN AT THE COST OF \$1.00 PER SAMPLE PER YEAR.
